For the past twenty years, Roger has been managing River Garden Farms, a large diversified farming operation in Yolo County, where he has been advancing <u>A New</u> <u>Way Forward</u> on sustainable farming that works in harmony with the fish and wildlife in the region. In this role he has managed surface water and groundwater resources for



the benefit of farming, communities, fish and wildlife. Working closely with the owners and staff, he partnered with local water agencies, government organizations, conservation organizations and many others to advance farming and provide functional ecosystems. Reclamation District No. 1500 was formed in April 1913 and provides drainage and flood control to 70,000 acres within 55 miles of levees between the Sacramento River and Sutter Bypass.

Sutter Mutual Water Company

(SMWC) was formed in February 1919 to operate and deliver good quality water from the Sacramento River to 46,746 acres of irrigated land through 200 miles of canals and 500 turnouts. It has appropriative water rights and a settlement contract with the Bureau of Reclamation.
